# Clergy Support Fund Handbook

*Revised June 2, 2026, by Diocesan Council*

## Rationale for Clergy Support Funds

The health and stability of our clergy and their families are vital to the work we do in our congregations. We understand that clergy often experience the very same financial struggles as those they shepherd, while under the added pressure of visibility in the church community. This burden often leads to shame, guilt, and a reluctance to communicate financial needs or request help.

Our goal in providing a Clergy Support Fund is to reduce the economic challenges of our clergy, while maintaining your privacy and dignity. As you have been bearing the burdens of your church, let us help to bear yours.

## The Purposes of the Clergy Support Fund

The Clergy Support Fund provides limited, temporary relief from economic challenges.

1. Necessary medical care for the clergyperson and/or immediate family members
2. Personal financial shortfalls needed for household expenses (mortgage, rent, utilities, food)
3. Bereavement and funeral expenses (including travel) for immediate and extended family (parents of the clergy or spouse)
4. Participation in an [ACNA Clergy Financial Wellness Cohort](#) (up to \$250)
5. Mental healthcare for clergy and immediate family members (up to \$1500 per year, provided through Clergy Wellness Initiative Vouchers)

If the needs of any clergyperson exceed \$3,000 in one-year, additional assistance will require a consultation with the Bishop to address the full scope of the economic challenge(s).

## Tax Implications of Receiving Support

The Internal Revenue Service (IRS) has regulations regarding the taxation of gifts and compensation that could result in penalties for both clergy and the Diocese if not properly administered or reported. To avoid any unexpected tax burden or penalties, we have sought the counsel of a Certified Public Accountant and established the following best practices.

1. Requests must include documentation of expenses the Clergy Support Fund is asked to cover.
2. Whenever possible, Clergy Support Fund payments will be made directly to third-party entities on behalf of the clergyperson (e.g. the Diocese will make direct payment to your doctor for medical expenses).
3. All payments made to clergy or their providers are “benevolent gifts.” They are not considered as remuneration for services. As such, there is no expectation of repayment for these gifts and they will not be reported as taxable income.
4. We will NOT make Clergy Support Fund payments through cash or gift cards.

## Confidentiality and Documentation

To ensure your privacy, trust, and dignity, personal information will be handled with the utmost discretion. The Bishop, the Canon to the Ordinary, and the Director of Administration/Diocesan Treasurer will be the only persons with knowledge of the specific disbursements.

The Diocese has established a system for proper documentation which will maintain your privacy and effectively distribute benevolent funds. The Diocese utilizes Salesforce, Formsite, and Microsoft Office 365, products with excellent reputations for maintaining security. Detailed records of all transactions, including applications, approvals, and disbursements, will be maintained to ensure accountability, track the allocation of funds, and serve as a reference for future requests and evaluations.

# How to Apply for Funding

Our goal is to ensure that we are providing aid to those who genuinely need it and to allocate our resources responsibly. Documentation helps us verify the circumstances and needs of the applicants, ensuring fairness and transparency in our support process. We also strive to balance this need for verification with a compassionate approach, recognizing that excessive bureaucracy can be discouraging and burdensome for those seeking help. By keeping our documentation requirements straightforward and respectful, we aim to maintain the dignity of clergy applicants while ensuring that our Clergy Support Fund efforts are effective and efficient.

## EXPENSES NOT RELATED TO MENTAL HEALTH

The following steps highlight the process of applying for funding for any purpose other than mental healthcare.

1. Submit the Clergy Support Fund Request Form at <https://www.adpgh.org/clergy-resources/>.
2. The Bishop and Canon to the Ordinary will evaluate the request and notify you of its status.
3. If your request is approved, we request an acknowledgement of receipt of funds, as well as appropriate updates on your and/or your family members' progress.

## MENTAL HEALTH EXPENSES

Samaritan Counseling, Guidance, Consulting, in agreement with the Anglican Diocese of Pittsburgh, is offering subsidized counseling specifically for clergy families of the diocese.

This agreement recognizes that clergy and their families grapple with a unique set of issues that makes finding the right therapist difficult because many therapists don't adequately understand clergy issues.

For over 42 years as a pastoral counseling agency, Samaritan has specialized in faith-based psychotherapy. It has been at the forefront of addressing clergy issues through its years of experience as well as its ongoing Caring for Clergy and Congregations program designed to address clergy issues.

Per this agreement, the Anglican Diocese of Pittsburgh and Samaritan agree that:

- The Diocese will subsidize up to 12 counseling sessions annually per family for clergy, their spouses and dependent children at a Diocesan rate of \$125 per session fee (\$1500 total), which is a \$25 reduction per session of Samaritan's typical \$150 private. Clergy families who

choose to continue therapy can use their own health insurance to subsidize the cost of ongoing therapy beyond the diocesan subsidized sessions.

- Clergy and their family members participating in Samaritan counseling are confidential clients of Samaritan in compliance with the Health Insurance Portability and Accountability Act of 1996 (HIPAA). The Diocese will not have access to names or any confidential information pertaining to participating clergy.
- The Diocese will distribute voucher numbers to each clergy member of the Diocese. The voucher number verifies for Samaritan that the holder is a clergy member of the Anglican Diocese of Pittsburgh.
- To access counseling, clergy clients should schedule an appointment by calling Samaritan at 888-200-9746.
- After an initial over-the-phone information intake, clergy clients should share their voucher number and desire to utilize the collaboration Samaritan has with the diocese.
- Samaritan will invoice the Director of Administration/Diocesan Treasurer for the sessions. No names of clergy or confidential information will be shared in this summary.
